included in the total price.

- d) The rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.
- e) The Prices shall be quoted in Indian Rupees only

3. Each Bidder should submit only one quotation.

4. Validity of Quotation

Quotation shall remain valid for a period not less than 15 days after the deadline date specified for submission

5. Evaluation of Quotation

The Purchaser will evaluate and compare the quotations determined to be substantially responsive i.e. which

(a) Are properly signed; and

(b) Conform to the terms and conditions, and specifications.

(c) The Quotations would be evaluated for the entire item together.

GST in connection with sale of goods shall not be taken into account in evaluation.

6. Award of Contract

The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.

- 6.1Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract
- **6.2** The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
- 7. Payment shall be made immediately after delivery of all the videos as per specification and after the testing done at CAAST-CSAWM, MPKV, Rahuri.
- **8.**The logos, design, text, images and multimedia material (audio and video) provided with the RFQ letter and in subsequent meetings are property of CAAST-CSAWM, MPKV, Rahuri. Distribution of this is strictly prohibited.
- **9.**The material for creation of video (i.e images, photographs, music files, small video clips with script) if required, will be provided in the portable hard disk to the successful bidder/vendor for carrying out the aforesaid work. These videos are property of CAAST-CSAWM, MPKV, Rahuri. Distribution of this is strictly prohibited.
- 10. The successful bidder/vendor need make video shooting (using the video recording and drone camera) of the Laboratory, field, technology or our climate smart village, script writing, direction, editing, animation and complete the video creation work.
- 11. The created videos, scripts, design, raw videos are also property of CAAST-CSAWM and distribution of this is strictly prohibited. You need to sign *non-disclosure agreement* for this.
